- Update on Sewer Counter Counter was repaired and is back in working condition. Byron confirmed we will be using water totals for June and July as there has been little to no rain.
- Payloader Bucket Lokken mentioned he could set up to get the piece cut for the bucket and welded back on.

City Clerk Report

- Town Hall Rental There is a request to rent the Town Hall in November. Council determined to open it up and clean the building before the event. It will be winterized afterwards.
- Harvest Festival Council discussed whether or not to have a festival every year. It was
 determined to hold it the 3rd weekend of September every year and to form a community club
 to help with planning.

Public Comments

• Trees in front of the Goose Bar- Discussed complaints of the trees in the right of way between the Goose Bar and HWY 7/59. The trees are obstructing the view of driver's entering the highway. It was determined to move them to the city park. The landscaping was also discussed and a decision was made to ask the Goose Bar if they would like to take over the maintenance for the flower beds. If they decide not to take over, the plants would be moved as well.
